1. Public Safety Radio System Upgrade

Budgeted Amount: \$1,506,078 (FY 2021)

Budget Line Number: 11-405-5610 (General Fund)

Project Lead: John Gabaldon

- Scope of Work
 - To equip and furnish radio equipment at VRECC to allow the Village of Los Lunas to join the New Mexico DoIT 700 MHz statewide system.
 - Motorola is proposing to integrate the Los Lunas dispatch center into the NM DoIT ASTRO 25 Core. To facilitate the integration, a new microwave link is proposed from Dispatch to Capilla Peak. The proposal includes updates to the dispatch center, new network equipment, and a new IP Logging recorder/Archiving Interface Server.

Status

- The project is over 90% complete.
- Motorola is working with NMDoIT to install the Microwave at Capilla Peak. The install is going to create a change order due to the need to add unforeseen electrical circuits.
- Parts for control stations at the F.D. are coming in this month. Once they are in,
 Motorola will install heads at Stations 1 and 2.

Schedule

- NMDoIT and Motorola are working on scheduling the installation of a repeater site at VRECC. Once complete, there will be some acceptance testing before we transition over to the new system.

 Center, including a second gymnasium, locker rooms, restrooms, and multi-use classroom space.

 Possible purchase of vacant property on east side of library, and ditch easements from neighboring homes.

Status

- o Directed by Council at Virtual Council Workshop/Retreat on March 27, 2021, to put funding in FY 2022 budget for library property acquisition.
- Spoke to Larry Guggino on 5/15/2021 to see if survey had appraisal amounts. He stated we have an appraisal but it was too old. Appraisals take about two months. He also stated I should contact the NMDOT to see if they would turn over rights to Sais Park that is situated on the corner of the Sais property to the east of the library.
- o Appraiser quoted \$11,000 because five properties have to be appraised.
- Contacted Larry Guggino for additional contacts for appraisals. He suggested utilizing the property tax values to determine a price. I asked him to move forward on that.
- Sent follow up message on September 2, 2021. No reply from Village attorney on status of property values. Will contact again.

- Seek appraisal in May 2021.
- o Contact NMDOT in July 2021.
- Seeking property tax values in lieu of appraisals August 2021.
- Present Mayor and Council appraisal information to determine if we make offer on properties.

- JAMF was purchased to remotely control iPads. Waiting for IT to deploy and train staff.
- 14 PCs are up and running. Waiting for remaining 6 in STEM Lab to be setup.

- September 14, 2019 the Friends provided the Facebook funding agent with account information and are waiting for the funds to be dispersed.
- Friends organization signed contracts and received word that \$175,000 will be transferred to their account after December 1, 2019.
- o February 2020 place orders for new equipment and furniture.
- o March 2020 begin renovation of teen room and current computer lab.
- April 2020 purchase equipment and furniture.
- o May 2020 ordered additional equipment, furniture and install equipment.
- June ordered STEM robotics, task chairs, charging station, Wi-Fi antennae, printers, and displays
- o August 2020 Obtain quotes for installing Cat-6 and additional electrical outlets.
- o Contract with educator to teach STEM activities. (Delayed due to COVID-19).

10. Gallegos/Archuleta House Stabilization and Preservation

Budgeted Amount: \$40,000 (FY 2022)

Budget Line Number: 16-411-5650 (Lodgers Tax Fund)

Project Lead: Erin Callahan

- Scope of Work
 - Develop and carry out necessary work to stabilize and preserve the historic Gallegos/Archuleta House for future Route 66 Museum and Visitor Center.
- Status
 - Facility Maintenance Division removed flooring in the house, and found that the floor joists and subfloor are in worse condition than anticipated, and also constructed in an unusual way that they do not connect to the foundation.
 - o On October 5, 2021, we held a virtual meeting with Francisco Uviña and another licensed architect, Phillip Gallegos, to discuss our findings in the structure.
 - On October 12, 2021, we met on site with the team including Phillip Gallegos, and determined that despite the floor not being constructed in the most logical way, the adobe seems to be structurally sound and the house is not going to fall down. The most important thing we can do is to find keep the vegetation away from the foundation and find a way to ensure water drains away from the structure. Facilities feels we can accomplish this with a French drain.

- On October 8, 2021, Bixby gave us notice the high mast pedestrian poles will not be shipped out until December 12, 2021. Project construction expected to start December 2021 with completion by March 2021.

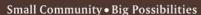
